

WALKING WITH PURPOSE

As I am writing this, I have a little over three weeks in my service rotation as Area 56 Delegate. I am very grateful for the opportunity I have been given to serve the Area and I have learned so much in the past two years. I hope I have achieved some measure of spiritual growth as well, but I am not always in the best position to determine that.

First and foremost, on behalf of Area 56, I need to offer my amends to the groups and the GSRs of Area 56. During the rotation before this one (2014-2015), we reorganized the structure of the Area, and reduced the number of Assemblies held each year. At the time, we recognized that communication would be a crucial element in the success of the new structure, and yet, we did not do a good job these past two years in reaching out to the groups through the GSRs to keep communication going. The Area Committee has learned that we have to do a better job, or else the service structure in Area 56 as a whole suffers. So, as I say, I am offering an amend which will include a commitment to maintain better contact with the groups in the coming two years. The Area needs to rely on the groups, too. We need your GSRs and we need their input to understand what the group conscience of Area 56 truly is.

Here are some highlights and information I want to share with you. At our September 2017 Assembly, we held our elections for the panel serving for 2018-2019. Jenny C., from Middletown, has been elected our Delegate to the General Service Conference. The other officers are: Dave L., Yellow Springs, Alternate Delegate/Area Chair; Andrea H., Montezuma, Registrar/Corresponding Secretary; Bob McM., Mason, Treasurer; and Sandy H., Cincinnati, Recording Secretary. We are finishing up the process of appointing Standing Committee Chairs and you should hear more about that soon.

At the same Assembly, I reported on the litigation pursued by AA World Services, Inc. and the General Service Board to claim the original printer's copy of the manuscript of the Big Book, which is currently privately owned. The manuscript was headed for public auction and AAWS filed a restraining order to prevent that while ownership of the manuscript was established. AAWS felt that it had evidence which showed that we are the actual owners of the manuscript, based on some correspondence in the Archives, even though we have never had possession of it. The latest news is that AAWS has filed a motion to dismiss the lawsuit. The hearing for this motion will not be held until February 2018. All court filings for the lawsuit are public documents. If you want to read them for yourself, go to iapps.courts.state.ny.us/iscroll/. Enter the string of characters shown on the right side of the screen to show the site you are not a robot. The case number to enter in the box "index number search" is 652676-2017. The documents are all downloadable.

Plans and preparations are already underway for our next Area Mini-Conference. This is the annual event where we review and discuss items which will be under consideration at the annual General Service Conference in New York in April. The 2018 Mini-Conference will be held March 16-18 at the Marriott in Dayton, where it has been held the past several years. More information about this will be forthcoming; a registration flyer is included with this newsletter. Any member of AA is welcome to attend and participate; this is not restricted to GSRs. There is no cost to register. We need to hear your thoughts and ideas! Our new Delegate will need to know what the Area thinks about a variety of issues, so please show up and let her know. As always, we will have a fabulous hospitality room, as well as a guest from the General Service Office. Our East Central Regional Trustee, Mark E., formerly of Lebanon, OH, will also be in attendance.

The schedule of Assemblies for 2018 is as follows:

Mini-Conference Preparation. Saturday, February 17, 10:00-4:00. This will be when items for discussion at the Mini-Conference will be introduced. There are important agenda items already set which have followed on the Fellowship's reaction to AAWS initiating legal action without consulting the General Service Conference.

Unity Day. Saturday, May 19, 10:00-4:00. This day is when we celebrate our unity as a fellowship in Area 56. We typically include participation with both the Cincinnati and Dayton Intergroups. Service in all forms is a way to strengthen unity and to carry the message to the still-suffering alcoholic. The Delegate will give her report on the Conference at this event.

Area Inventory. Saturday September 15, 10:00-4:00. This will be an important meeting, where we will get a sense of whether the Area is getting back on track after this rotation or not. We conduct an inventory every other year and rely on our GSRs to tell us what we are doing right and what we are doing wrong.

The most important thing I hope you take away from all this is that we need you at Area 56. We need participation from the groups and we need to hear what you are thinking. Please elect your GSRs, send them to the Area Assemblies, and listen to their reports back to your group. AA as a whole depends on the informed group conscience which is generated in the groups, communicated to the Delegate at the Area and then expressed at the General Service Conference. The only way to get that group conscience is for as many people as possible to participate in the conversation.

One thing I heard at my first Conference is this: I can pretend to care, but I can't pretend to show up. For me, learning to show up for AA service -- first in my home group, then to outside service commitments -- has shaped my ability to show up for the rest of my life, whether I want to or not. I have had so many amazing (and some not-so-amazing) experiences in the nine years I have been in service at the Area level that I couldn't begin to list them all. I started as a GSR and took the time to learn what it was all about. I continue to learn as I go. Now it is time to rotate out, and I am grateful for that, too. I will continue to show up, but in a different role. And I am grateful for that, too. Thank you all for the opportunity to be of service, for saving my life, and for giving me a life worth living. See you at the Mini-Conference, if not before!

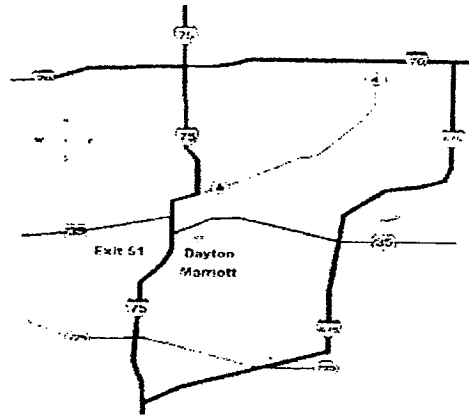
